### Other Site Characteristics

**Sector EN de la costa Menorquina situado al N de la ciudad de Mahón. Es una zona de pequeñas colinas de relieves poco pronunciados formado por materiales del Paleozoico con algunos afloramientos más modernos en el extremo E (La Mola), donde las calizas**

forman unos acantilados importantes. La zona está poco poblada y el acceso a algunas áreas costeras estaba restringido hasta hace poco por ser zona militar. Hacia el interior encontramos el típico hábitat mixto de la isla de Menorca, que alterna zonas de cultivos y áreas de matorral y bosques

En esta zona existe una importante colonia de Pardela Cenicienta e importantes poblaciones nidificantes de otras aves incluidas en el Anexo I de la Directiva 79/409/CEE

Área Natural de Especial Interés, según la Ley 1/1991, de 30 de enero, de Espacios Naturales y de Régimen Urbanístico de las Áreas de Especial Protección de las Islas Baleares. El Plan Territorial Insular de Menorca (aprobado en mayo de 2003) consolida la figura de ANEI, definiendo además Áreas de Alto Nivel de Protección (encinares, bosques de acebuche, zonas de protección costera, maquias de aladierno, zonas húmedas, islotes, sistemas dunares, acantilados, vegetación rupícola litoral, reservas marinas y barrancos. Toda la isla de Menorca está declarada Reserva de la Biosfera por el Programa MaB de la UNESCO desde 1993.
